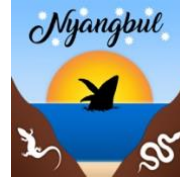

Official Lore Notice

By Grandmothers Lore: the superior Lore/Law on the aniuima (land) of the Continent known as 'Terra Australis' and "Australia"

Know that living men and women cannot treaty with a corporation. Only sovereign to sovereign can treaty. The original tribes are in pactum [treaty] with each other through their language, songlines and dreamings of all tribes across earth. We are not in pactum with the Corporate system. Only living beings having a conscious existence can treaty. Corporations and citizens are dead entities. You, being the living man, woman or agent, who is served with this Notice under Lore are informed that crimes of genocide are being committed upon our aniuima (land) today.

Senior Tribal Lore man Uncle Juma of the Larrakia has served Notices that are now in silent acquiescence by "Australia Corporation" Government. Juma's statement is attached and served on You. It has been stamped by the Supreme Court Darwin and is unrebutted. Fact. In the Westminster system of law this unrebutted Statement of fact (Affidavit) stands as truth in commerce, truth in law and judgment in Law. Fact. The letter to WIPO and IP Australia also attached prove that the federal government and all states and territories cannot trade in anything hence why the EU rejected Australia's trade agreement. Fact. The Customary tribal Court determination destroys the Commonwealth constitution(s) and is binding as it is stamped by the internationally recognised Maori land Court.

Lastly the Letter to all Monarchy, Heads of state and embassy's is Notice and Knowledge. Now the guilt of knowledge is also transferred to everyone, here and now, of the cruel and inhumane acts of the past and present governments ongoing. The Pope and the Vatican have repudiated the doctrine of discovery nullifying colonisation. And the lie of terra nullius is well proven.

The evil "systems" and living agents who are inflicting harm upon us, the Sovereigns, and all people of the aniuima (lands) are established and clear. We are recording these crimes with International Lawyers. Now it is time for you as a man or woman to choose. Will you choose harm, loss and injury to others? Right from wrong? Good or evil? The facts are given to you in this Notice with the attached documents. Your choice now decides, will you be complicit in crimes of genocide? Our Sovereign Lore is: first do no harm. All will be accountable under Lore. Continued perpetration of harms upon the people on our aniuima stops now. Slavery and genocide stops now. It is done. Ykja wani mida – You have been told.

Re: Open Letter re Child Abduction, State Sanctioned Abuse, Trafficking & Genocide on Terra Australis

I am Juma of the Larrakia people of Majagi, co-head of State with my counterparts from Tiwi and Brinkin. I am a true holder of the Marratia (grandmother) and Koolpinyah (grandfather) ancient language and law. I am writing this in English, but English is not my mother tongue. I write and read iconologically. This holds the true stories and law of our ancient ancestors and the maps that connect us across countries, continents and universes. These are the songlines that connect the juua kuaa (jaka – ie the families' families). In English – we are all one family!

Our most important resource is our picannini's (children). It is the responsibility of all cultures / governance systems, to protect our children. Unfortunately, this is being degraded by an evil sinister system of governance in the country known to you as "Australia". As "Australia" is not registered on the land, they are a foreign entity and have no jurisdiction over myself or any other sovereign being on our aniuima (land). They are in breach of the law of this land and international and universal laws, by the forced removal of children from one group to another, and many other unlawful acts they are perpetrating on both the tribal and nationals of this land, by use of force. Under International law, this is classified as genocide. They are also committing forced slavery since they illegally entered our international waters and came onto our aniuima. This is proven in their own documentation and high court decisions:

- King William IV - Letters Patent - 19th February 1836
- Queen vs Campbell 1983
- Mabo No.2 vs Queensland 1992
- Northern Territory v Arnhem Land Aboriginal Land Trust 2008
- Love v Commonwealth of Australia; Thoms v Commonwealth of Australia 2020

The British Westminster Court system themselves ruled, in Ruling iii in the Chancery Division of the High Court in London on Friday 25th June 2004 that "Letters Patent, issued under 'The Great Seal of Australia,' by Her Majesty Queen Elizabeth II, Queen of the United Kingdom and Northern Ireland, appointing a Governor General in Australia, have been issued incorrectly." Thus, the acting "Governor General" holds no executive powers whatsoever, and all current "Australian Laws" assented to on behalf of a British Monarch by the "Governor General of Australia" do not hold any valid or legal executive authority, and are, in legal terms, ultra vires.

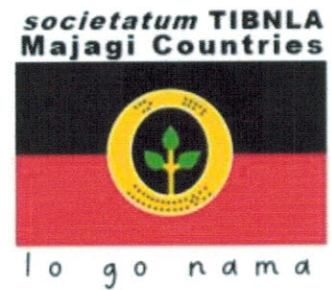
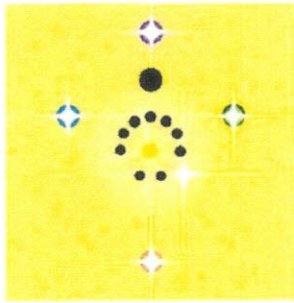

CUSTOMARY LAW NOTICE

6th Day of January 2023

Ref MTT000555

The **United Tribal Countries Land Alliance** is a custodial tribal law council made up of self-governing Original Tribal Countries from this continent (known as Terra Australis or Australia) that have reconvened their ancient *pactums* through their shared languages, dreaming and songlines, which connect all tribes on this continent, and beyond. We have re-established our *Original Tribal Councils* and have made public announcements, staking our claims¹, as self-governing countries on our *aniuima* (ancestral lands), which we have had an unbroken bloodline connection to for millenia.

On the 6th January 2023 *Custodial Tribal High Court* was conducted in accordance with autonomous ancient custodial traditional protocols with several original crown in right tribal elders / law men from their respective countries attending, Yolngu elders, dancers and yidaki performers, as well as an International Human Rights Ambassador & Observer as witness. The following items were presented, discussed and determinations of truth made regarding:

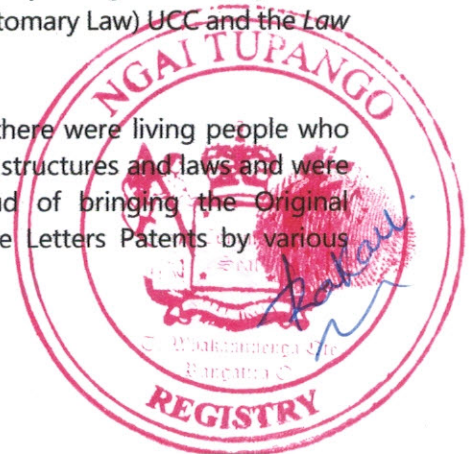
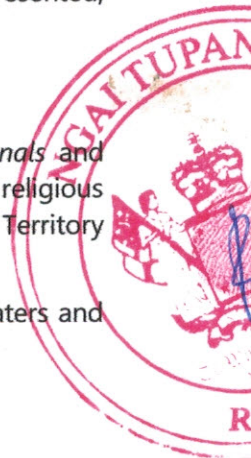
1. Lawful standing of the *Original (Indigenous) Tribal Countries*.
2. Crimes against Humanity towards *Original (Indigenous) Tribal People, Sovereign Nationals and Foreign Residents / Refugees* perpetrated by the British Crown, the Vatican and other religious organisations, Commonwealth of Australia (Australian Government and all State / Territory Governments).
3. Trespass and destruction of our people, culture, sacred emblems, sacred sites, lands, waters and airways.

The findings were as follows:

1. The *Original (Indigenous) Tribal Countries* are the only entities with lawful standing on the continent known as Terra Australis (Australia), based on *Djobijakabi* or *Original (Indigenous) Custodial Tribal Law* and the ancient principle / universal legal maxim *prior in tempore, potior in iure* or "*First in Time, First in Right*". The *Djobijakabi* (law) that was already on this land is still here and is therefore the HIGHEST law of this land (continent). It will always stand above any foreign law or legislative "act". This is also consistent with International Humanitarian Law (Customary Law) UCC and the *Law of Nations*.

British colonists fraudulently used "Terra Nullius" knowing full well there were living people who already had rights to their countries, had (and still have) governance structures and laws and were trading internationally, which is why they perpetuated the fraud of bringing the Original (Indigenous) Tribal People under the *Flora and Fauna Act*, despite Letters Patents by various

monarchs instructing them to treaty with, protect and pay for their land (see South Australia letters Patent² as one example).

Terra Nullius was debunked during MABO II, but the High Court of Australia stated they couldn't rule against a law system that underpinned their own existence. We have determined that the High Court of Australia has no standing on this continent and our collective *aniuima* therefore any and all of their decisions are hereby dismissed forthwith.

When Batman treated with the Waa-Wurrung Chief Elder, it was fraudulently overturned by the Colonial Governor of the time citing the *Doctrine of Discovery* (see attached info sheet) which had recently been used in USA in the 1823 Supreme Court decision – *Johnson v McIntosh* – Marshall CJ:

Christian nations assumed ultimate dominion over Americas and upon "discovery" the American Indians lost "their rights to sovereignty, as independent nations".

Courts in Australia have cited the *Johnson v McIntosh*, in cases such as *Fejo v Northern Territory* and *Western Australia v Ward* as a basis for not recognising *Original (Indigenous) Tribal People's* rights to their own lands, governance, law and trade / commerce. The *Doctrine of Discovery* was repudiated by the Pope and formally renounced by the Vatican on 30th March 2023, removing any perceived legal basis for foreign countries, states, or nations to take and/or control *Original (Indigenous) Tribal* owned land.

Our court determined that the Vatican, the United States, the British Crown, The Australian Governments (federal, state and territory) and any and all other foreign countries, states or nations, town councils, religious organisations, private members associations, unions, companies, associations, corporations, banks, trusts, militaries, pirates and their foreign "laws", and their agents, heirs or successors, ALL have no standing, authority or permission to be on our collective *aniuima*.

2. Genocide has been committed since 1788 and has continued to the present day, against *Original (Indigenous) Tribal Countries & Peoples* on our collective *aniuima's*. This is documented (but not limited to) the attached list of massacres. Forced removal of children from one group to another this is not limited to the *Stolen Generation/s*.

The Federal Family Courts of Australia and Family Services' organisations in each state and territory have been found guilty of child abduction, trafficking, child abuse, and child deaths in care. It was determined that the Local and Supreme Courts of each State and Territory of Australia have been found guilty of forced slavery, false imprisonment, deaths in custody, conspiracy to pervert the course of justice, and benefitting from the proceeds of crime.

3. It was determined that the Australian Government, and all other foreign countries, states or nations, religious organisations, private members associations, unions, companies, associations, corporations, banks, trusts, militaries, pirates and their foreign "laws", that are on our collective *aniuima*, have been found guilty of the crimes of trespass and desecration/destruction of our people, culture, sacred emblems, sacred sites, lands, waters and airways. The Australian Government and all State/Territory Governments and all Town Councils' Coat of Arms, using our sacred emblems have been reclaimed and protected by trademark. They can no longer be used for any purpose.

All documents stating our claims on all of the above have been served either physically or via registered mail and publicly announced, and all have come into tacitly accepted acquiescent agreement.

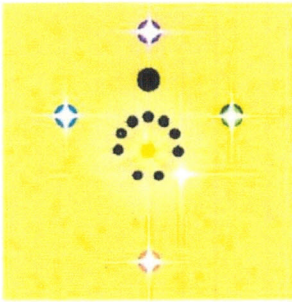

RE: OFFICIAL NOTICE OF DIRECTION TO CORRECT ERRORS & UPDATE RECORDS

We write to you as members of the **United Tribal Countries Land Alliance** to introduce ourselves as Original Crowns in right of the Independent Self-Governing Countries **TIBNLA of the Majagi, Nyamal Widagura Putalyirri, Narrunga / Ngarrindjerri / Kurna / Noongar, Jagalingou, Nyangbul, Yanggu, Waa-Wurrung, and Palawa South East Tribe** on the terrain known to you as *Terra Australis* (or Australia). This terrain's history since colonisation has been built on fraud, misrepresentation and without honour. The Original (Indigenous) Custodial Tribal Soverains and Sovereign Nationals have claimed their unalienable God given rights and privileges to self-determination, cultural, social, political, and religious freedoms under *Original Custodial Tribal Law, Customary International Humanitarian Law* and the *Law of Nations*.

Our members have reconvened their ancient *pactums* through their shared languages, dreaming and songlines, which connect all tribes on this continent and beyond. We have all staked our claims by placing our Countries Flag's and Coat of Arms into our Tribal Estates, Mother Earth, such as the example shown here https://www.youtube.com/watch?v=QF_JoEbf-1M&t=38s. As per the *Law of the Belligerent*, we have informed the belligerent occupiers that we are the "returning sovereign" and informed the BAR Association and all body politics that their services are no longer required.

We have declared Peace! and reconvened our ancient treaties with foreign countries, Independent Original (Indigenous) Custodial Tribal Soverain Countries, and Sovereign non-citizen Nationals. We are all in compliance with the Montevideo Convention on the Rights and Duties of States, and we have informed all quasi-Australian Federal State and Territory Governments and their departments, acting agents, assigns, nominees, heirs and successors, including the British Crown, US Corporation, the Vatican, and the United Nations, of our Lawful standing.

This official notice informs you that our *Seeds of Governance* and our *Original Custodial Tribal Law* has never been ceded on the terrain known to you as *Terra Australis* or "Australia", and we have continued to this date to conduct our Original Tribal Customs' Law Ceremonies and Traditions despite the continuation of attempted genocide being perpetrated on us by belligerent foreign occupiers.

TIBNLA is a *Private Members Association* which represents the three tribes of the Majagi Countries. These tribal countries consist of Tiwi, Brinkin and Larrakia. Their motto is '*Lo go nama*' which means "do no harm" in English. TIBNLA have informed and recorded all information with international Countries and bodies, including yourselves (WIPO & IP Australia) and through Article 6ter by accession to the Paris Convention. Under their governance structure, TIBNLA have instituted the **TIBNLA Patent and Trademark Office** to protect ALL of our sacred emblems and intellectual property from further destruction and desecration. This is official notice that the following images have been protected as follows:

- TIBNLA of the Majagi have taken ownership of the image formerly known as the "NT (Northern Territory) Coat of Arms" or "IP Australia Trade mark -9001645"
- Nyamal Widagura Putalyirri have taken ownership of the image formerly known as the "WA (Western Australia) Coat of Arms" or "IP Australia Trade mark -90001644"
- Narrunga / Ngarrindjerri / Kaurna / Noongar have taken ownership of the image formerly known as the "SA (South Australia) Coat of Arms" or "IP Australia Trade mark -90001641"
- Jagalingou have taken ownership of the image formerly known as the "QLD (Queensland) Coat of Arms" or "IP Australia Trade mark -9001640"
- Nyangbul have taken ownership of the image formerly known as the "NSW (New South Wales) Coat of Arms" or "IP Australia Trade mark - 9001639"
- Yanggu have taken ownership image formerly known as the "ACT (Australia Capital Territory) Coat of Arms" or "IP Australia Trade mark -9001647" and the image formerly known as the "Coat of Arms of the Commonwealth of Australia" or "WIPO Article 6ter Circular No. 5320 File 2005/12484"
- Waa-Wurrung have taken ownership of the image formerly known as the "VIC (Victoria) Coat of Arms" or "IP Australia Trade mark - 9001642"
- Palawa South East Tribe have taken ownership of the image formerly known as the "TAS (Tasmania) Coat of Arms" or "IP Australia Trade mark -9001643"

Please ensure that all your member states contracting partners, personnel are informed, and all records are updated directly and required changes forwarded forthwith.

I, Juma (Jimmy Fejo) of the Larrakia, being the Undersigned, do solemnly swear, declare, and depose:

1. THAT I am competent to state the matters set forth herein.
2. THAT I have first-hand knowledge of the facts stated herein.
3. THAT all the facts stated herein are true, correct, and certain, admissible as evidence, and if called upon as a witness, I will testify to their veracity.
4. THAT the eternal, unchanged principles of Law are:
 - a) A workman is worthy of his hire.
 - b) All are equal under the Law.
 - c) In Law, truth is sovereign.
 - d) Truth is expressed in the form of an Affidavit.
 - e) An un rebutted Affidavit stands as truth in Law.
 - f) An un rebutted Affidavit becomes the judgment in Law.
 - g) All matters must be expressed to be resolved.
 - h) He who leaves the battlefield first loses by default.
 - i) Sacrifice is the measure of credibility.
5. THAT any and all of the various papers, documents, adhesion contracts, or "agreements" I may have signed with any government agency or entity or any others that might be construed to indicate a conclusion contrary to my herein-below assertions were made, signed by me on the basis of mistake due to lack of full disclosure creating a deliberate lack of full knowledge, a deliberate action of fraud, non-disclosure, concealment of material fact, and misrepresentation. Such action thereby creates a stressful situation of duress and intimidation, vitiating all documents by such action of fraud.

6. THAT I, Juma (Jimmy Fejo) of the Larrakia, am the ordinary executive, homosapien, with bloodline connection to my Terrain and the irrefutable head of state of my tribal boundaries, sole and absolute owner of myself, my body, and my estate, and possess unconditional, allodial, sovereign title thereto, and that I abjure, renounce, forsake, and disavow utterly and absolutely now and forever all presumptions of power, authority, or right by any governmental agency, its Principals, over the rights, life, liberty, freedom or property of this Affiant from whatever source presumed or derived.
7. THAT I, the Affiant, am NOT a Legal Fiction Person (as defined in a Law Dictionary) or some other kind of Partnership, BUT INSTEAD a living breathing, sovereign, flesh and blood Human Being with a living soul, with a distinct Mind that is capable of possessing personal knowledge.
8. I am the sovereign, senior elder / lore man of the Larrakia tribe.
9. My land is called Majagi. It includes, but is not limited to, the areas commonly called Darwin, Ludmilla, Parap, Nightcliff, Casuarina, Palmerston, as well as outer regions including Wagait Beach, Dundee Beach, Belyuen, Southport, Gunn Point (Three Point), Jabiru, Adelaide River, Fountain Head & Pine Creek.
10. There are three tribal groups, the Marratia, Jungalaba & Gammiajaki, that combined are known as the "Larrakia".
11. The Larrakia are the owners of Majagi.
12. Jaka oo is the family's family's lore of the great grandfather (Jaka Kuaa) and great grandmother (Djuaa Kuaa).
13. Djuaa Kuaa is the mother of the land mass currently known as Australia.
14. I am a true holder of the Marratia (grandmother) and Koolpinyah (grandfather) lore.
15. My tribal lore is "first in time, best at law" since time and eternity.
16. On the 13th of May 2016 a Notice of Rebuttal, of which I was a signatory, was served on the Prime Minister and Governor-General of Australia, and the Chief Minister and Attorney General of the NT, by registered mail, giving 28 days for rebuttal.
17. This notice was acquiesced by silence.
18. The notice was re-served 28 days later by registered mail, and was again acquiesced by silence.
19. A Notice of Acquiesce by Silence was served on all parties by registered mail.

20. A Cease and Desist / Trespass Notice, of which I was a signatory, was served by hand on the Northern Territory Government (at Parliament House), and the Administrator of the NT (at Government House, Darwin) on the 11th September 2020, as recorded on video¹.

21. A Declaration of the Returning Sovereign, of which I was a signatory, was served by hand on the 21st September 2021, to the Commander of Northern Command, of the Australian Defence Force, at the Larrakeyah Defence Precinct, Larrakeyah NT as recorded on video².

24. It is within my authority as a senior lore man / elder to invalidate any transfers of, or dealing with, property, rights and interests of any description whatsoever (a) which are or have been situated in the territories which have come under the occupation or control, direct or indirect, of the belligerent foreign occupier, or (b) which belong or have belonged to persons, including juridical persons, resident in such territories, whether such transfers or dealings have taken the form of open looting or plunder or if transactions apparently legal in form even when they purport to be voluntarily effected.

25. NOTICE is hereby given, and demands made, that:

a) ALL Larrakia Tribal Terrain occupied unlawfully, in violation of our tribal lore, and in violation of directions in the Letter/s Patent (and instructions given by their king/s) or otherwise converted, sold, or seized by the Belligerent Occupier or other Parties in collusion therewith, be immediately returned, and all historical and outstanding rents paid, all artefacts returned, damages recompensed, and rehabilitation of the said terrain, to the original Owner, the Undersigned Affiant;

b) All Parties who proceed to act or assist in said actions, against this Affiant, without thorough, verifiable, point-by-point rebuttal of each and every point set forth in this Affidavit shall be immediately charged with criminal fraud, theft, conspiracy of extortion, theft and fraud, and commercial liens shall be placed against all their real and personal properties (defined crimes: criminal conspiracy, robbery, misprision of felony, conspiracy against the rights of peoples, extortion, fraud and false statements, and other such crimes as are related to issues of RACKETEERING plus such Constitutional violations not listed combined and described simply as TREASON); and

26. THAT failure to respond as herein required to this Affiant, within the herein a prescribed time of thirty (30) days will be deemed by this Affiant to invoke the doctrine of acquiescence and admission, to recover, in commerce, the lost or damaged properties plus, but not limited to, damages, penalties and costs.

27. THAT this Affidavit is the ONE AND ONLY such Notice and Warning. If all actions are not abated within thirty (30) days, or if at any time in the future any actions are reinstated, it shall be considered a wilful disregard for this Notice and Warning, and such shall engender the immediate filing of Criminal Complaints (Affidavits of Information) and Commercial Liens (Affidavits of Obligation) against all parties involved.

28. THAT the foundation of Commercial Law, being based on certain eternally just, valid, and moral precepts, has remained unchanged for at least six (6) millennia. Said Commercial Law forms the underpinnings of Western Civilization if not all Nations, Law, and Commerce in the world, is NON-JUDICIAL, and is prior and superior to, the basis of, and cannot be set aside or overruled by, the statutes of any governments, legislatures, quasi-governmental agencies, or courts.
