We ask that everyone make 2 calls a day to "Department of Child Protection". For the emails where the text is red, amend to include what was said, then return text to black, or purple before sending.

Calls to--- (08) 8124 4185 from 8am

Phone - record the call

Is that the Department of Child Protection? Part of the Australian Government?

I'm sorry, what was your name (get full name if possible) and what is your position?

My name is (first name only) I am making a welfare check on 2 offspring, your department has unlawfully stolen from the living woman Cecilia Agnes.

Do you currently have in your possession Phoenix and Hunter?

Under what authority do you claim you have the right to steal her property when Phoenix and Hunter are not registered on any Australian Government register, and there is no accusations or evidence of any child abuse of any kind ??

Is it, or is it not, the priority of the DCP to uphold the health and safety of the children in all matters?

Does not your legislation state that "children" should be with their "parents" whenever practicable?

Then why, when there are no allegations, nor any evidence, of any forms of abuse to Phoenix and Hunter has the DCP stolen the children from their mother and father, thus causing the children unnecessary stress and trauma, especially when both offspring are still breastfeeding?
