The Stolen Generation 2.0

Date known as 6 February 2025

Who can forget the “Stolen Generation” where, for more than 60 years, between 1910 and the 1970’s, without authority, without consent, the Australian Government forcibly removed indigenous children from their families?

More recently, the global scandal of the weaponisation of the US Department of Justice against its dissenters, against the people, against those who did not comply with the policies and agendas of the incumbent “Government”, has rocked the foundations of Justice systems around the globe.

Would it be acceptable, or legal, for any Government to steal the children from a family because they are Catholic, or Muslim, or Buddhist? No, it wouldn’t!

Would it be acceptable, or legal, for any Government to steal the children from a family because they vote liberal, or labour, or independent? No, it wouldn’t!

Would it be acceptable, or legal, for any Government to steal the children from a family because the family elected and decided not to contract with a Corporation? No, it wouldn’t!

The South Australian Government, through the Department For Child Protection (DCP), in collusion with the Federal Family Court of Australia have conspired to steal ‘Phoenix’ and ‘Hunter’, the breast-feeding biological creations of ‘Cecilia’ and ‘Clinton’, from their care, simply because someone else wants custody of ‘Phoenix’ and ‘Hunter’.

There are no accusations, nor police reports of allegations of child abuse of either ‘Phoenix’ and ‘Hunter’ by either of their biological creators ‘Cecilia’ and ‘Clinton’. With a complete lack of authority and jurisdiction, and in a complete abuse of process and power, Judge Stewart Brown of the Family Court has acted in collusion with the DCP, he has ignored ALL documentation submitted by 'Cecilia' and 'Clinton' challenging the authority and jurisdiction of the court over them and over 'Phoenix' and 'Hunter', he has ignored ALL documentation submitted by 'Cecilia' and 'Clinton' challenging the civil claim (of "custody/ownership"), refused 'Cecilia' and 'Clinton' to speak on any issue, exhibited a complete bias in the interests of the court, not 'Phoenix' and 'Hunter' and, in a complete abuse of process, abuse of power and abuse of the spirit of the law, weaponised the Family Court of Australia against its dissenters, against 'Cecilia' and 'Clinton', against 'Phoenix' and 'Hunter'.

The Stolen Generation is unfortunately still with us. It is just version 2.0 and no-one's offspring are safe.
