Re: Armed Kidnapping of ‘Phoenix’ and ‘Hunter’,
being the biological creations of Cecilia Agnes

The Office of the Consulate of the People of Terra Australis has been alerted of the following:

1. It has come to the attention of this office that, on the date known as “4 February 2025”, agents of the corporate entity “DEPARTMENT FOR CHILD PROTECTION” ABN 54 598 525 171 did kidnap the biological creations ‘Phoenix’ and Hunter’, born of the living woman ‘Cecilia Agnes’ and the living man ‘Clinton Lee’, both of whom are recorded with The People’s Court of Terra Australis, as identifying as indigenous to Terra Australis, and
2. The corporate entity “DEPARTMENT FOR CHILD PROTECTION” ABN 54 598 525 171 has no authority on the Land of Terra Australis, and
3. That the corporate entity “DEPARTMENT FOR CHILD PROTECTION” ABN 54 598 525 171 has no authority on the Land of Terra Australis, has been recorded and served on all “Governments”, and their “Departments”, of “Australia” through the Grandmother Lore document (GM Lore Notice attached), and
4. The living woman ‘Cecilia Agnes’ and the living man ‘Clinton Lee’ have both rebutted any and all contracts, be they real or implied”, with all “Government” entities and corporations, and
5. The biological creations ‘Phoenix’ and Hunter’, born of the living woman ‘Cecilia Agnes’ and the living man ‘Clinton Lee’, are not registered with any “Government” corporation, and
6. No allegations or evidence of any “child abuse” by the living woman ‘Cecilia Agnes’ and/or the living man ‘Clinton Lee’, against the biological creations ‘Phoenix’ and Hunter’, born of the living woman ‘Cecilia Agnes’ and the living man ‘Clinton Lee’, has been presented to them or to any lawfully constituted court, therefore

7. There was no lawful authority or justification for the biological creations 'Phoenix' and Hunter', born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', as thus the property of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', to be seized, stolen, or kidnapped, and
8. This action shows a continuation of the "Australian Government's" past Stolen Generation agenda, now condemned by all, and
9. The actions of those involved constitute war crimes as defined by the Geneva convention, and
10. The biological creations 'Phoenix' and Hunter' born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', whom are both still breastfeeding, have been denied emotional and subsistence support from their biological creators, the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', to the detriment and emotional angst of the creators and their creations, and
11. The aforementioned addressees have a fiduciary care to the biological creations 'Phoenix' and Hunter' born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', and
12. The biological creations 'Phoenix' and Hunter' born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', are indigenous to Terra Australis and valued in our community, and
13. The biological creations 'Phoenix' and Hunter' born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', are being held in "custody" as chattels, against their will and without the consent of their owners, through and by unlawful and enforced misjoinder and in breach of International Law in regards to modern-day slavery, and
14. At an emergency convening of the People's court of Terra Australis, held date known as "5 February 2025", the People's Court of Terra Australis (Australasia) being the superior court of the land did require unanimously that the biological creations 'Phoenix' and Hunter' born of the living woman 'Cecilia Agnes' and the living man 'Clinton Lee', be released and returned to their biological creators immediately, that is no later than 6pm date known as "5 February 2025", and
15. The failure by the aforementioned addressees to abide by this requirement shall be taken, under Tacit Acquiescence, as an admissions by all the aforementioned addressees that they are complicit in the war crimes being perpetrated, and to any such sentence or punishment determined by this, or any international court.
